

## St. Paul's Staff

**Jim Potts** - Jim began his work as Organist and Choirmaster of St. Paul's in 1995. In recent years our staff has become smaller and St. Paul's has come to rely on Jim to contribute his skills and knowledge about worship and about our building in new ways. For the last several years, in addition to leading our music program, Jim has created all of our service leaflets and has overseen maintenance of, and repairs to, our building and mechanical systems.



**Doug Mouncey** - Doug first worked as an administrator at St. Paul's from 1987-2005. Between 2016 and 2020 St. Paul's reduced our staff by more than one full-time position for the long-term financial health of the parish, yet we knew there would be 'loose ends' that would need to be covered. At the end of 2020 Doug stepped up to handle many of these loose ends, from assisting the rector with programs, to applying for grants, to overseeing parking lot usage. Doug does all of this work as a volunteer. Although his staff title is *Administrative Assistant* a more

accurate title might be Guardian Angel!

**Judy McAdoo-Pelton** - Judy is our Operations Manager. A member of our staff since 2011, Judy handles all of our financial transactions, builds and maintains our website, organizes and maintains program records and materials, creates contracts and works with outside groups, creates all sorts of communications materials (from *The Courier* to brochures to electronic and paper posters), and is the central person for internal and external communications at St. Paul's. Judy brings order and competence to our operations.





**Derek Lane** - Derek has served as our loyal security person since 2014. Derek skillfully handles one of the toughest assignments for a church in the heart of the city: treading the difficult path of welcoming everyone, while trying to keep our members safe, and our worship services focused on worship.

**The Rev. Philip Major** - Fr. Philip came to St. Paul's in 2016 to serve as our rector. His leadership responsibilities include worship, pastoral care, administration, and communications.





**Cyrus Grant** - Cyrus and his team from Dovesview LLC have served as our cleaning contractors since 2020. Tammie Demperio is the hard-working woman we most often see faithfully running the vacuum and mopping the floors, doing her very best to keep St. Paul's clean and tidy, even in the midst of an enormous construction project.

**Mark King** - The pandemic restrictions that began in March of 2020 prompted us to begin to build our current camera and microphone system to make our worship services available to people in their homes through our YouTube channel. Mark King brought his technical expertise to our efforts and began serving as our regular technical engineer in June of 2020. Mark continues to improve our LiveStream broadcast and makes it possible for everyone with a home internet connection to participate in worship.

# Minutes of the 2023 Annual Meeting Respectfully Submitted By Julia Fine Clerk of the Vestry

#### **Call to Order**

The annual meeting was held on January 29, 2023 and was called to order by Father Philip at 10:30 a.m. and he introduced officers of the meeting:

#### Approval of minutes of January 30, 2022 Annual Meeting

Marion Greenhalgh made a motion to accept the minutes as presented and Jessica King seconded the motion. The motion was passed unanimously.

#### **Report from the Nominations Committee**

This year, the nominations committee is headed by co-chairs Dick Pilgrim and Rebecca Livingood. Dick as the presider, named the other members of the committee, then he presented the nominees for a Junior Warden and three open Vestry positions. To comply with the bylaws, Dick presented two motions:

**Motion 1** *-Junior Warden Nomination*: Dick Pilgrim moved to approve Marion Greenhalgh for Junior Warden. Betsy Elkins moved to close the nomination and cast a single unanimous ballot to elect Marion as Junior Warden. Jim Doyle seconded that motion, and the motion passed with one abstention from Tom Major.

**Motion 2 -**3 *Vestry Positions* – Dick made a motion to approve *Barbara Bell, Matthew Van Meer* and *Joe Moorman* to fill the 3 open positions. There were no nominations from the floor so David Webb made a motion to close the nominations, and Cathy Wolf seconded the motion.

David Webb made another motion to cast a single unanimous ballot to elect these three nominees to serve as Vestry members - serving full terms. Harry Lewis seconded the motion. The motion was passed with one abstention. There were no further nominations from the floor.

#### **Rector's Report**

Fr. Philip began by acknowledging and thanking Mark King for his skills and expertise in setting up the live stream. He also expressed gratitude for a grant received from the Nan Door Fund that made it possible to purchase the necessary equipment needed for the live stream

Father Philip's topic centered on the lessons we learned as we endured this once-in-a-lifetime pandemic. He reflected on the past three years and how the intrusion of the pandemic positively changed each of us. He said "we learned new lessons about the importance of gathering together in person for worship and fellowship and observed that the pandemic inadvertently created a changed in perspective; and that "we have emerged from the pandemic – a people changed by God's love."

#### **Treasurer's Report**

Doug Mouncey- Treasurer, reported on the generosity of donations received, and he thanked everyone for the tremendous financial support for the last several years and throughout the pandemic. Doug also highlighted some of the major areas of additional revenue during the past few years that helped to defray some of our costs. He referenced the income and expense report on pages 12 thru 14 of the annual report, highlighting 3 major revenue sources of the past few years:

• *Grants* – which helped to support the missions of St. Paul's Church.

- Pledges and plates generated 30% of our total revenues and exceeded our budget by \$6,000.
- Rental revenues: Our hosting venue for organizations such as Symphoria, Syracuse Friends of Chamber music and others, and rental parking fees-which generated the bulk of St. Paul's revenues.

Doug also commented on the dual win-win situation that was inadvertently created by renting out our sanctuary: (1) It helped to increase visitors to our church as well as increased membership. (2) It helped to reduce our shortfall which was usually at 5% - down to 3%.

In summary Doug stated that the year 2022 can be considered a huge success financially, and he also acknowledged the work of the finance committee, the Vestry, and especially Judy McAdoo-Pelton - Operations Manager.

#### Update on the Open Doors Project

Father Philip explained some of the reasons for delays that were experienced during the past 12 months. The project was estimated to be completed by the end of 2022. However, he said that the Church continues to receive pledges and contributions from members and friends of St. Paul's for a total of \$1.8 million as of the end of December, 2022.

#### A Tiny Home for Good

The concept of utilizing the second floor of the parish house came to fruition during the delay of the *Open Doors* project. Discussions began with *A Tiny Home for Good* for the construction of ten efficiency apartments, offices, and a community room. Fr. Philip said that "pursuing this ministry offers St. Paul's Church the opportunity to make a large impact in our community for the lives of people with the greatest need." The Tiny Home project will be incorporated in the *Open Doors* construction.

#### **Acknowledgements and Gratitude**

Father Philip acknowledged and expressed his gratitude for his staff and volunteers, and observed how they worked closely together as a team during the pandemic to get things done efficiently, and he credited Doug Mouncey for his efforts in significantly lowering expenses.

Fr. Philip also expressed appreciation for the ministries and lay leaders, naming the Altar Guild and the Sunday School teachers as examples, as well as referencing the importance of our choir - in addition to their creation of great music, he is thankful to be sitting in close proximity to them during worship. Fr. Philip also acknowledged that the physical isolation we experienced during the pandemic has helped us to emerge from the pandemic - a people changed by God's love; making us aware that our primary task "is to care for one another".

Father Philip officially thanked four people who have fulfilled their terms on the vestry: Bill Pitcher, Michael Mach, Elizabeth Handler, and Dick Pilgrim

The meeting ended at 11:37 a.m., after a closing prayer from Father Philip.



# Ieva Doyle Nomination for Vestry




# Rector's Report By Rev Philip Major

t is my privilege to once again submit this Annual Report as Rector of St. Paul's Church. This is my eighth Annual Report to you. My primary message to you is that 2023 was marked by significant growth in two areas: our mission and our congregation.

#### St. Paul's Mission

In our baptismal covenant (BCP p. 305) we pledge to seek and serve Christ in all persons, loving our neighbors as ourselves. This is our mission. As we begin 2024, I suggest five ways the people of St. Paul's are accomplishing our mission:


- 1. Our members **care for one another** through conversations, phone calls, physical and practical support, letters and notes to one another, and visits at home or in care facilities.
- 2. Our members contribute labor, food, and dollars to stock *The Open Pantry.*
- 3. Our members **serve people outside of St. Paul's**, from *The Samaritan Center* to *The YMCA Senior Apartments* to the place where you work or volunteer.
- 4. Our members **lead the ministries and the practical work** of the church, as witnessed in the reports in this book.
- 5. Our members have supported and led the work for *Open Doors*. Construction began in October of 2023 and will be completed by the end of 2024. Allow me to elaborate on the ways *Open Doors* is key to the mission of St. Paul's.



As of January 2024, we expect the most significant expansion of our service to God's people in the coming decade will be through our ministry partnership with *A Tiny Home for Good*. (see p. 24) One year from now, in January of 2025, we expect *A Tiny Home for Good* will have begun construction of ten apartments, community rooms, and office facilities for their staff on the second floor of the Parish House. This is a long-term plan to fulfill our mission to serve God's people. This new ministry would be not possible without *Open Doors*.

#### St. Paul's Congregation

A second area of growth has been in the size and diversity of our congregation. Though we have experienced the loss of a few of our dearest friends and members in 2022-23, more than 25 people have begun worshipping regularly at St. Paul's congregation in the past two years. Worship attendance was 20% higher in 2023 than in 2022.



Our new members continue a trend we have observed in previous years: many of our members have significant experience in other branches of 'The Jesus Movement' (a term I first heard from our Presiding Bishop, Michael Curry). These new members are drawn to St. Paul's by:

- \* the warm welcome they have received.
- \* the health, transparency, and intentionality of our governance.
- \* diverse opportunities for Christian formation, fellowship, and service.
- \* the many meaningful aspects of our liturgy, including the music.

In other words, our new members are drawn to St. Paul's for the same reasons as previous generations of members.

New members who have become active since the Covid pandemic include several young children, including two who were born to active members in the last several years. Thanks to the leaders of our Godly Play program, we have young children participating in worship and Sunday School almost every week.

We give thanks for God's many gifts to us, but especially for the gift of being together, seeking to be the Body of Christ in this place.

## Executive Ministry Team By Fr Philip

ost Episcopal Churches are led by a Vestry (or similar body) which functions more or less like the Congress of the United States is supposed to function, creating the rules and making financial and programmatic decisions. Most Episcopal Churches have a small staff, usually including a priest and a music leader, and sometimes an administrator and a custodian.

St. Paul's has an extra team of leaders, not found in most other churches. It's called the Executive Ministry Team. In 2023, the Executive Ministry Team included:

- \* the convener of the Mission & Service Team Betsy Elkins
- \* the convener of the Community Fellowship Team Liz Belden-Handler
- \* the convener of the Worship Ministry Team David Morgan
- \* the chair of the Pastoral Care Team Kira Dirghalli
- \* the Treasurer Doug Mouncey
- \* the Wardens Marion Greenhalgh and Dick Pilgrim
- \* the Rector


The Executive Ministry Team has two functions: responding to the immediate needs of the congregation (including during a crisis such as the Covid Pandemic) and considering the needs and work of the congregation in the coming year. St. Paul's Executive Ministry Team helps St. Paul's be responsive to the present and proactive, planning for the future.

#### Senior Warden's Report By Dick Pilgrim

'm finishing an unusual three-year term as warden since I was asked and appointed by the Vestry to fill Rebecca Livengood's second year as warden (her Senior year in 2023) just after having been warden for two years myself (2020-2022). She had asked to be relieved of that duty to spend more time on the Open Doors project, and I was happy to oblige.

Significant within those years was helping to keep the church's ministries moving ahead even as our rector was on a well-earned sabbatical leave (Part I in 2022 and Part II in 2023), as well as being increasingly active in the Open Doors administration in 2023. Signaling both these factors was my signing – on behalf of the church and in our rector's

absence – the primary contract with Drulyk Construction Co. for implementing the Open Doors project in Fall, 2023.

t. Paul's is so fortunate! Why you say? Besides our congregation, we have the best staff running and maintaining the church. You don't always see them or what they do, but they put in many, many hours of hard work. Let's start with **Judy McAdoo-Pelton**, our Operations Manager. But, that's no small task in itself, constantly practicing the organ, and working with the choir every Thursday evening and before the 10 am and special services. Did you know that he is now also doing the weekly and special/holiday church programs? He also meets with the contractors needed to keep the building running, and he is on the Flower Committee. Part-time! Running our live-stream cameras and operations is **Mark King**. Many people, especially those who can't get to the church for whatever reason, rely on watching the service online, and Mark makes that happen. He is now taking on the job of IT Consultant as well. And don't we feel safer with **Derek Lane** watching out for our safety? If he isn't working his other job, he's at St. Paul's keeping an eye on the church and the people. Finally, our cleaning service contractor is **Cyrus Grant** and his crew. Cyrus ensures that our church is cleaned every week. Not a small task considering what's going on inside the buildings these days.

Then we come to the staff who are not paid anything. They do their job for our benefit and because they are dedicated to St. Paul's. The first one is **Jeanne Avery**. Jeanne runs the nursery and Sunday school. She develops the program for the class and does so many additional things for the kids, and they love her! She's



ur Vestry meets monthly to provide practical, legal, and spiritual guidance for St. Paul's Church. Each year at Annual Meeting three members are elected by the congregation to serve 3 year terms.

\* In January of 2024 Kira Dirghalli and Rebecca Livengood are finishing their terms.

- \* Tom Cantwell, Michael Mach, David Morgan have one year remaining in their terms.
- \* Barbara Bell, Matthieu von der Meer, and Joe Moorman have completed the first year of their three-year terms.
- \* Doug Mouncey served as Treasurer and Julia Fine served as Clerk of the Vestry in 2023.

Each year one Warden is elected to serve a two-year term. Our Wardens do all of the work of Vestry members, plus they meet several times each month with the Rector to consider the immediate and long-term needs of the congregation and to help lead specific aspects of the administrative work, such as guiding revisions to our Policies & Procedures Manual. In January of 2024, Marion Greenhalgh is completing her first year as a Warden, while Dick Pilgrim is completing a third year as Warden, having been appointed by the Vestry to finish the unexpired term of Rebecca Livengood.

Though this system may appear to be complex, when we follow the rules established in our Bylaws and Policies & Procedures Manual, St. Paul's has leadership and a governing board that is resilient and strong:

- 1. There is a measure of continuity each year, as some members are serving the second or third years of their terms.
- 2. Fresh energy and new insights are brought into our leadership each year.
- 3. Since the Wardens and Rector work together, and the total body of the Vestry is twelve members, there is depth in all aspects of our administration and oversight.

Your Vestry is responsible for many of the practical and legal details of St. Paul's, including:

- appointing members to serve in critical positions, such as convention delegates.
- approving bids for contracted services and repairs to the church
- overseeing the development and execution of church programs
- creating a budget for the following year.

For the first time in my experience as a priest, during 2023 a member of our Vestry died during the course of her service. Carolyn Grieb, our beloved sister and friend, was a true servant leader. Carolyn was diagnosed with cancer in the fall of 2022. At the time I asked her if she would like to step aside from her work on the Vestry. Carolyn responded that she would continue serving as long as she was able.

Carolyn's passion was to support St. Paul's in our work of serving God's people in great need in the center of the crossroads of Central New York. Carolyn was passionate about the work of *The Open Pantry* and our evolving partnership with *A Tiny Home for Good*. Carolyn did everything she could to make sure these ministries, our Sunday School, and other vital programs of the church were fully supported. Carolyn died on September 4, 2023, just a few weeks after participating in our August Vestry meeting.

#### Financial Report By Doug Mouncey, Treasurer

During a Sunday service in December 2023, I was reminded of two things.

First, we need to be constantly mindful to look for the small, good things in our lives (particularly in the face of so much that is negative and any inconvenience as a result of the Open Doors construction).

Second, "all things come of thee, O Lord..."

Our financial report provides a monetary summary, but it is only a small piece of life at St. Paul's during 2023. All the reports for this Annual meeting provide a much more illuminating picture of what we're about. Our finances are simply one of our resources.

My belief is that our footprint... the impact of St. Paul's in our community and world far exceeds most congregations of our size!

Adjacent to this narrative report is a summary of our income and expenses compared to our budget for 2023.

#### **INCOME**

We are grateful for the support of our members: Pledge & Plate income exceeded the budgeted amount Miscellaneous Donations: for example, designated contributions for altar flowers, Friends of Music, Samaritan Center

Program Donations: in addition to the generous support of individuals for our Outreach activities, we received small grants from Music for the Mission, Episcopal Diocese of CNY, InterFaith Works, and food from the InterReligious Food Consortium. Developing relationships and partnerships of this sort is not only recognition of our work but also allows us to provide additional service to individuals in need.

Earned Revenues: includes rent from the parking lot and organizations, like Symphoria, that use our facilities

Other Income: St. Paul's receives a portion of the annual income of the Sandford Trust

#### **EXPENSES**

Total Salaries & Related Expenses: one reason for being underbudget was fewer hours worked by some hourly employees

Total Occupancy Expenses: underbudget due to savings in utilities, real estate taxes, and commercial insurance

Buildings & Grounds Expenses: there was a significant savings due to the sound system project being funded by designated gifts

Total Outreach Expenses: much of the designated income and corresponding outreach expense is related to the Haitian Education Mission. This effort is like the growth of the Samaritan Center where we are providing non-financial support to this group as they seek IRS status as a separate not-for-profit organization. They have conducted significant fund-raising efforts with their partners beyond St. Paul's.

Support from Key Investments: because we exceeded our income and expenses being less than anticipated, we had less of a need to transfer funds from our investments account. 
# Buildings and Grounds By Bill Pitcher



Contributions to this fund in support of our musical offerings are always greatly appreciated.




#### Worship Ministry Team By Fr Philip

The Worship Ministry Team meets 9-10 times each year, planning for upcoming services and special events in light of the needs of our congregation.

#### Altar Guild By Fr Philip

y their faithful service, the members of St. Paul's Altar Guild consecrate the chancel and altar area. They are true servants of God, working individually or in pairs to prepare the altar and chancel area for worship. You may not notice their presence in the worship service, but the Altar Guild member is the person who came to church the day before, or earlier in the day, long before anyone else, even the priest, arrived. The Altar Guild member is often the last person to leave the church building after worship is over; they work alone or in pairs to carefully store the consecrated bread and wine in the aumbry, wash the dishes, refill the candles with oil, change the linens, change the altar frontal, and pick up the leaflets and little bits of garbage left in the chancel after the worship service.



The Altar Guild functions behind the scenes of every worship service, and we have many worship services at St. Paul's: Sunday Holy Eucharist at 8 and 10 a.m., Ash Wednesday, Maundy Thursday, Good Friday, Easter Vigil, Thanksgiving, Christmas Eve, Christmas Day, Evensong, Lessons & Carols, Weddings, and Funerals.

In 2023 St. Paul's Altar Guild was led by Julia Fine. As the director of the Altar Guild, Julia trains new members and takes responsibility for many of the extra worship services, such as funerals and weddings. - We sent 40 new hymnals to the Episcopal/Anglican Church in San Miquel de Allende, Mexico.
- We are establishing a covenant partnership with A Tiny Home for Good, a local organization that provides housing and support for individuals at risk of homelessness.

# Open Doors Project Management By Betsy Elkins and Rebecca Livengood


fter years of planning and work behind the scenes, construction for our Open Doors Project began at the end of 2023.

The Project Management Task Force (charged with planning and administering the construction phases of the project) and The Steering Committee (charged with overseeing everything) worked throughout the year to bring us to that wonderful day when the "shovel went in the ground."

- Construction bid documents and drawing were completed by our architects Crawford and Stearns.
- Requests for bids were issued and received.
- Spaces were cleared in the parish house (including a parish workday in June) to allow for construction work.
- An application for a bridge loan was submitted to help with cash flow during the project.
- A contract was signed in September with Drulyk Construction to complete the project.
- A groundbreaking event was held on October 17 and Construction work began! (See the church website for videos
  of the remarks made that day.)
- Significant abatement work has been completed and another round will take place in early 2024.
- Demolition of many spaces has been completed.
- Monthly job meetings are being held throughout the project with the architect, the contractor, and representatives from St. Paul's.
- The Project Management Task Force and Steering Committee continue to meet monthly as well.
- We anticipate the work will be completed by the Fall of 2024.
- Regular construction updates appeared in the Courier, the weekly e-blast and church service bulletins as well as on the church website.

## Open Doors Capital Campaign By Cathy Wolff

he first half of 2023 was devoted to the Project Management Task Force working on the bid phase and securing a construction contract with our contractors, Drulyk Construction (read more about this in the Open Doors Construction Report). Until we received their bid, we did not know what the actual cost of the Open Doors Project would be. All the estimates we had been working with were from 2019, before the pandemic.

The actual costs of all phases of our project resulted in some difficult choices. A compromise was reached that resulted in an income plan recommended by the Open Doors Steering Committee and approved by the Vestry on June 13, 2023, that called for an additional \$190,000 to be raised. The next few months revealed the need for some changes to our income plan. As of October, we calculated that we needed to raise \$298,000 to cover the costs of the project.

A highly successful Groundbreaking Event was held on October 17, 2023, at which our Rector Philip Major announced our partnership with A Tiny Home for Good (ATHFG). Featured speakers included Andrew Lunetta, executive director of ATHFG, Syracuse Mayor Ben Walsh, and me. Thanks to parishioner Tim Cassavaw and his colleague Nicolas Murphy of Hunt Real Estate, you can view a video of all the remarks on our website under the Project Videos button. You can also read Philip's and my remarks in the November 2023 Courier newsletter.

Since the Groundbreaking Event, the various fundraising Task Forces are once again ramping up to complete our Capital Campaign with the assistance of our consultant from Partners for Sacred Places, Bridget Fidler. Tom Cantwell chairs the Individual Donor Task Force, Marion Greenhalgh chairs the Diaspora Task Force, and David Ridings chairs the Community Task Force. Debbie Nettle continues to serve as Open Doors Administrator.

Our partnership with A Tiny Home for Good gives us a strong mission component, particularly for fundraising within the community. It is also providing new grant opportunities and other means to help reach our goal. As of December 12, 2023, we have already raised \$13,600, reducing the goal to \$284,400!

Many factors have made the duration of this Capital Campaign longer than any of us anticipated. The finish line is finally in sight. Construction has begun. Open Doors is really happening! St. Paul's members have already demonstrated astonishing generosity to Open Doors. For those of you who are new to St. Paul's, we hope you will join us in supporting Open Doors. For those of you who have already given generously, we ask you to consider making an additional donation to ensure that St. Paul's is an accessible place of community engagement, service, and worship for generations to come.

Why are we providing a three year report in the above numbers? First, our Capital Campaign began in earnest in early 2021 with many pledges paid shortly thereafter while others continue to the present. Second, although there were many expenses associated with the campaign and construction planning since 2021, the major construction costs did not begin until Fall 2023. In other words, income was significantly higher than expenses until 2023 when the reverse has been true.

Due to the magnitude of The Open Doors Project, financial support and project expenses have been maintained in a separate book-keeping data base (i.e. Open Doors Project funds are not comingled with our general operating funds). Elsewhere in the Annual Meeting booklet, there is a separate financial statement for the general operations in 2023. Also, throughout the year, separate contributions statements are distributed (one for the general Pledge and other gifts throughout the year; and, a separate statement for those who have made an Open Doors gift that year). Once your Open Doors pledge was completed, those statements were no longer sent.

# A Tiny Home for Good By Betsy Elkins


hroughout the year a task force appointed by the Vestry met with members of the Tiny Home for Good (ATHFG) staff and board to discuss what a partnership would look like between St. Paul's and A Tiny Home for Good. This group included Fr. Philip Major, Doug Mouncey, David Morgan, and Betsy Elkins.

What started as a "what if this were to happen" idea is becoming a reality. After our Open Doors construction project is completed, we plan to turn the second floor of the Parish House over to A Tiny Home

for Good. They will build 10 tiny

apartments, some common space for residents (including a kitchen) and space for staff (case workers who will assist the men living in

these apartments.)


between ATHFG and SPC. While this won't be implemented until construction begins, likely in early 2025, it is important that we can articulate exactly what our landlord/tenant relations will be. Our partnership will be unusual in that we will be charging very little rent (only \$1 a year) to ATHFG. Much of the work of Open Doors will

directly benefit ATHFG including the removal of asbestos, installation of an elevator, restoring windows and replacing the roofs over the parish house. ATHFG will then take on the financial responsibility for building and managing the

apartments that they will lease to tenants. In addition to a legal agreement (a lease) we are also agreeing upon some rules and regulations for tenants and some mechanics of how the partnership will work.

The law firm Barclay Damon is working with us (SPC) to write the lease agreement. Our lawyer has indicated that our partnership is new and unusual with no model for us to follow. And our lawyer agrees the partnership is wonderful and we will make it work. Before we sign a lease, a memorandum of understanding to more formalize the discussions/plans, will be signed between the two organizations.



he Open Pantry opened in August 2020 as a way to serve our downtown neighbors that we met through The Caring Place. Since the first day it was stocked with food, The Open Pantry has helped to feed our Downtown neighbors.

- 19 Every day more than 19 of our downtown neighbors come to The Open Pantry seeking food and/or personal hygiene items.
- 9 Each day, almost 9 households receive basic food and/or personal items offered by The Open Pantry.
- 2+ Each day, an average of 2.6 of our downtown neighbors donate to The Open Pantry by placing their items directly in The Open Pantry cabinet.

Thank you to everyone who takes a weekly turn restocking The Open Pantry including: Kira Dirghalli, Barbara Bell, Liz Belden-Handler, David Webb, Dick Pilgrim, Doug Mouncey, Betsy Elkins, David Morgan, Willson Cummer, Derek Lane, Michelle Breidenbach and Sue Wright.

The impact of The Open Pantry is so great that during 2023 The Open Pantry received three \$1,000

Emergency Food Supply Program (EFSP) grants. EFSP is a Federal Program administered by InterFaith Works. In addition, The Open Pantry received a \$1,000 Grant from Music for the Mission in February 2023. This was the third

year we received a Music for the Mission Grant.


ur Bible Study group met most Mondays at noon from January through May and October through December.


